Recommendation to Award
Building Department Addition:

Effective October 3, 2023, the threshold amount for rejecting bids when they exceed the original construction estimate will increase for certain Ohio public entities. Per the Ohio Revised Code, Section 153.12 no contract to which this section applies shall be entered into if the price of the contract, or, if the project involves multiple contracts where the total price of all contracts for the project, is in excess of ten per cent, in the case of a contract made by the state or a public board, commission, authority, or instrumentality of the state, or twenty per cent, in the case of a contract made by a county, township, municipal corporation, school district, special purpose district, or other political subdivision or a public board, commission, authority, or instrumentality of the political subdivision, above the entire estimate thereof, nor shall the entire cost of the construction, reconstruction, repair, painting, decorating, improvement, alteration, addition, or installation, including changes and estimates of expenses for architects or engineers, exceed in the aggregate the amount authorized by law.

In reference to the bid opening on June 10, 2025, for the Building Department Addition Project, it is the recommendation of Ankrom Architects LLC to award the lowest and best bid to D.E. Huddleston, Inc., P.O. Box 207, Chillicothe, OH 45601, in the amount of \$268,680.00. Huddleston, Inc. in the amount of \$268,680.00.
